Project Brief:

The Indian Institute of Public Health, Shillong is implementing a project entitled "India Primary Health Care Support Initiative" in collaboration with Johns Hopskins University.

- 2. Guide the Field Research Assistants during the data collection phase.

- 4. Conduct debriefing meetings with the field team to ensure quality of data collected and to adapt the interview guide if necessary
- 5. Provide inputs to understand the local context relevant to the project through existing literature
- **6.** Prepare interview guides for qualitative studies
- 7. Co-ordinate with local government personnel, health workers and village leaders for the purpose of research
- 8. Provide assistance and conduct trainings for research team members when required.
- 9. Any other project or institution related activities as may be assigned from time to time

- **11.** Maintain reports and update the PI and other team members of the progress of the team.
