#### **About IIPHS:**

The Indian Institute of Public Health Shillong (IIPH-Shillong) is a Northeast regional institute of public health. It was established in 2015 by the PHFI in collaboration with the Government of Meghalaya to redress the limited institutional and systems capacity in public health in the North East Region of India. IIPH-Shillong is an autonomous educational & research institute of the IIPH Shillong Society, registered under the Meghalaya Society registration Act of 1983.

#### **Project Title and Brief:**

## "Health system strengthening and community engagement to establish a model for Community-based Management of Acute Malnutrition (CMAM) in Meghalaya"

The Government of Meghalaya has invested heavily in infrastructure and staffing, with the state having nearly 6000 Anganwadi centers and over 10,000 Anganwadi workers and helpers. This project, funded by the Sachin Tendulkar Foundation, intends to create a model for CMAM that will ensure the effective and maximal use of these resources as well as appropriate access to Nutrition Rehab Centers (NRC) and the engagement of the community in the care of sick children. The specific interventions to include in the model have been gleaned from research and prior examples currently being proven effective in India. A largely cited resource in the selection of these specific interventions has been Niti Aayog's compendium of state-level approaches and practices to community-based care and management of acute malnutrition which details eleven thematic areas for focus in the development of a state CMAM program. These thematic areas have been incorporated into the planned model, resulting in a proposed ten-pronged, multi-sectorial, collaborative model.

This pilot of the Meghalaya CMAM Model wil be rolled out in selected blocks of the three districts, which have a substantial prevalence of moderate and severe wasting, acknowledging the diversity of ethnic and demographic groups in the state. This pilot program would allow the state to test-iterate-and-improve a program design for linking the CMAM and NRC program. As there is currently no program for community-based management of children with MAM and Uncomplicated SAM in Meghalaya, this project will work from the ground up with stakeholders to propose and develop the program design for convergence of CMAM and NRC guidelines (in consultation with GoM).

The success of this project, the development and implementation of a Meghalaya CMAM Model, will be judged on its effectiveness to reduce the development of malnutrition in all children under-5 as well as those specifically at-risk (defined by WHO). An additional outcome will be the effectiveness of the model in improving the time to resolution of malnutrition in both risk and non-risk groups. These two key outcomes will be evaluated using a cluster randomized study design in order to provide definitive recommendations as to the effectiveness of the CMAM Model.

In addition, implementation related measures of the project such as the reach of the intervention, the level to which it is adopted and the fidelity with which the model is applied, and certain indirect predictors of sustainability will also be evaluated. Finally, qualitative measures such as community awareness, satisfaction of end-users and the improvement of AWW/ANM capabilities and confidence in carrying out their duties will be clarified.
