**About IIPHS:**

The Indian Institute of Public Health Shillong (IIPHS) is a northeast regional institute of public health. It was established in 2015 by the Public Health Foundation of India in collaboration with the Government of Meghalaya to redress the limited institutional and systems capacity in public health in the North East Region of India. IIPHS mandates include research interdisciplinary education and advocacy.

**Project Brief:**

Vector-borne diseases (VBDs) such as malaria, dengue, chikungunya, leishmaniasis, typhus, and lymphatic filariasis impact nearly half of the global population. These diseases represent over 17% of all infectious diseases and are responsible for more than 700,000 deaths annually, with significant disability-adjusted life years (DALYs) lost, ranging from 82,000 to 46 million each year depending on the disease. VBDs disproportionately affect underprivileged populations and can be viewed as an eco-bio-social phenomenon, involving ecological factors like climate, biological factors such as the vector and transmission dynamics, and social factors including the human host's knowledge, attitudes, practices, poverty, demographics, and health systems. Hence the goal of the project is to empower the existing health system as well as the community for the prevention or control of vector borne disease through the implementation of evidence based digital Community Engagement and Risk Communication strategies.

**Job Description:**

Project Technical Support-III personnel will assist the Project Scientist with the community interventions and community engagement in their respective field site. They will also perform the data cleaning, analyse the qualitative and quantitative data and liaise with the Project Technical Support II for data collection.

**Essential Qualification:**

Master's Degree in Public Health (MPH), Master's of Social Work (MSW), Master's in Digital Communication Management, Mass Communication Programme or a related discipline.

**Work Experience:**

- At least 1 year of experience in field-based research, community engagement, or data management.

**Skills:**

- Proficiency in data cleaning and analysis, with experience using relevant software (e.g., SPSS, NVivo, Excel).
- Strong communication and interpersonal skills.
- Ability to work independently and as part of a team in challenging field conditions.
- Fluency in English and working knowledge of local languages (Khasi/Garo/Jaintia) is an advantage.

## **Work Conditions:**

- The position involves fieldwork in rural and urban settings, which may require extended periods away from the main office.
- Flexibility in working hours is expected to accommodate the needs of the community and project timeline.

- Engage with local communities to foster participation and collaboration in the project.

- Perform data cleaning to ensure the accuracy and completeness of data collected.
- Analyze qualitative and quantitative data collected from the field.
- Provide support in the interpretation of data and the preparation of reports.

### **3. Coordination:**

- Liaise with relevant stakeholders to facilitate effective and efficient data collection.
- Coordinate with other project team members to ensure that project objectives are met in a timely manner.
- Provide regular updates and feedback to the Project Scientist regarding field activities and data-related tasks.

### **4. Documentation & Reporting:**

- Maintain accurate records of all field activities, data management processes, and community interactions.
- Assist in drafting reports and documentation as required by the Project Scientist.

### **5. Other Duties:**

- Participate in team meetings and contribute to the continuous improvement of project strategies.
- Undertake any other tasks as assigned by the PI and CoPIs to support the activities of the institute
