IIPHS mandates include research interdisciplinary education and advocacy.

# **Project Brief:**

The Indian Institute of Public Health, Shillong is implementing a project entitled "Changing the Landscape of Soil-Transmitted Helminth Infections in India Using a One Health Approach" in collaboration with Christian Medical College Vellore.

# **Deliverables:**

# **Functional requirements**

- (i) Carry out nucleic acid extraction and PCR from human, animal, and environment samples for identification of parasites, vectors, and other related vector-borne pathogens.
- (ii) Carry out DNA sequence analysis for mining of genome-related information.
- (iii) Carry out immunological assays to detect and quantify substances, including antibodies and antigens.
- (iv) Carry out microscopic identification of parasites.
- (v) Responsible for preparing of prepare purchase orders and maintain stock inventory for all consumables/reagents.
- (vi) Responsible for safety and quality standards of the laboratory and for all related equipment
- (vii) Assist the team in preparing deliverables for the funding agency and primary research institute as and when required.
- (viii) The position would sometimes require field visits to study sites
- (ix) Any other project or institution-related activities may be assigned from time to time by the Principal investigator or immediate supervisor

# Liaison Requirement

Liaison with partner institutions, and government agencies as may be required, in consultation with PI.
