IIPHS mandates include research interdisciplinary education and advocacy.

Project Brief:

The Indian Institute of Public Health, Shillong is implementing a project entitled “Changing the Landscape of Soil-Transmitted Helminth Infections in India Using a One Health Approach” in collaboration with Christian Medical College Vellore.

Roles and Responsibilities:

- (iii) Co-ordinate with local government personnel, health workers, and village leaders for the purpose of research

- (vi) Maintain documentation for research procedures and findings for management review.
- (vii) Provide assistance and conduct training for research team members when required.
